Product classification: Intended for special nutrition, suitable for athletes

Flavour: green fresh

Organoleptic characteristics:

- *appearance, consistency:* green solution of syrupy consistency
- *taste:* distinctive sweet and sour, the exotic fruit feijoa
- *aroma:* characteristic for given flavour

Ingredients: sucrose, acidity regulator citric acid, water, naturally identical and artificial aroma of feijoa, white colour emulsion (E-445, E-330, E-211, E-202, E-1450, E-300, E-307), sodium chloride, magnesium gluconate, taurine, glycine, acesulfame K sweetener, color component* (E-104, E-133, E-330, E-211), monopotassium phosphate, sucralose sweetener, potassium sorbate and sodium benzoate preservatives, L-Carnitine base.

**Recommended dosage:**

10 ml of concentrate into 6,5 dcl of water

Usage:

- Use the enclosed measuring glass for the correct drink prepare
- Do not store the prepared drink for more than 24 hours
- Once opened, store at the temperatures between 8 to 15 °C and use within 3 months
